# Discuss Placing a Speed Bump on Will Road at Girot Lane

Mayor Kernc stated she received several complaints of motorists going very fast and not obeying the stop sign at Will and Girot Lane. Commissioner Adair stated he has witnessed this happening. Kernc stated she spoke to one of the residents and discussed the installation of a speed bump. She explained the drawback of installing one and the potential accidents this could cause. Commissioner Kasher stated since that is a truck route would speed bumps might be allowed. After discussion of options to assist in this matter, the decision was made to install a "stop ahead" sign and look at other stop sign options with either solar light and/or lights around the sign. Public Works Supervisor Jim Dunning will research the stop sign options.

# Discuss Putnam County Painting Estimate for Towers-Put out to Bid

Mayor Kernc stated this estimate is for the cleaning of the towers. Kernc would like to see the tower at Will Road cleaned since the Jewel development will be coming to Diamond. Commissioner Kasher stated he would like to wait until the Jewel Development is completed since the digging and moving of ground will be disrupted. This item was passed and will be revisited later.

# Discuss Putnam County Painting Estimate for Clarifiers-Put out to Bid

Mayor Kernc presented the estimate from Putnam County Painting in the amount of \$78,500.00. This item will go out to bid. Village Attorney John Gallo will prepare the bid packet. A consensus was reached to proceed with placing this item out to bid.

# Approve Country Meadows Snow Removal Agreement for 2023-24

Mayor Kernc stated a slight increase is reflected in this agreement. Kernc stated it has been many years since the village increased the cost. The cost is \$215.00 per hour and \$150.00 per salting occurrence and if fuel cost increases to \$4.50 per gallon, the fee shall increase by 10%. **MOTION** was made by Commissioner Kasher, **SECOND** by Commissioner Adair to Approve the Country Meadows Snow Removal Agreement for 2023-24. **All Ayes: Motion Carried.**

#### Public Works Department Updates

Public Works Supervisor Jim Dunning stated the VFD's should be installed on September 15, 2023. Synagro will start hauling the bio-solids starting tomorrow. The Public Works Department has been cutting around the plant and fence line and pulling trees, etc. The new water meter for Yes Communities(Burt Estates) is scheduled to arrive this week.

#### Clerk Updates

Village Clerk Lori Holmes stated the water meters for the water meter replacement project arrived. A Public Notice has been placed in the Courant and letters will be mailed in the water bills notifying residents of the project. United Meters will be mailing letters out on August 31<sup>st</sup> to those homes and businesses requiring a replacement meter. Work will commence in September.

# **Commissioner Warner**

Commissioner Warner distributed a proposal from Gasvoda & Associates for a new Wash Press and a proposal for re-building the current one. The rebuild cost \$69,843.00 and the cost for a new is \$84,065.00. Warner stated with the difference of \$14,222.00, he feels he would like to purchase new, which is his recommendation. Public Works Supervisor Jim Dunning stated he agrees, and the

warranty would be better. Mayor Kernc also agrees. This will be placed on the September 12, 2023, agenda.

#### Mayor Kernc

Mayor Kernc stated the EPA released 2 million dollars for lead service lines and would like to allow North Central Illinois Council of governments (NCICG) to complete the application and submit it for the village. NCICG is very successful at this process and has completed numerous applications in the past with a high success rate. She would like a consensus to move forward to allow NCICG to submit the application for the village for inventory lead services lines within the village. A consensus was given to have NCICG submit the application. Kernc stated Greg Ferrari purchased the old Midland States Bank. Kris Sayers of Beans and Bites would like to lease the building with option to buy. Kernc informed Kris and Lori Bonarek(who is on the board for Beans and Bites) they need a site plan, which needs to be completed by a professional architect. Then, a site plan meeting would take place with the village engineer, attorney, Mayor Kernc and the Zoning Administrator. They were informed that they cannot leave the gravel on the premises and specific information on the plan for the use. Kernc is trying to explain to those involved what the process and requirements would be. Kernc would like to arrange a meeting to discuss the development plan.
