Kernc stated, Diamond is responsible for a small section of the road which runs behind Burt Estates and on Will Road. Kernc stated there is a build grant which covers 80% of

costs under \$200,000.00. Kernc will investigate into the grant further. Kernc stated she does not know the scope, cost or any additional information regarding this purposed project.
