Engineer Updates

Village Engineer Mike Perry stated the Route 113 project and IDOT approval is in progress. Mayor Kernc interjected she was the negotiator for the STP1 project however, due to changes in procedures; she can no longer be the negotiator for STP2. Mayor Kernc would like to get a consensus to reach out for a negotiator to hire for this process. All Commissioners were in agreement to proceed with hiring a negotiator.

Maintenance Updates:

Maintenance Supervisor Bill Wethington acknowledged Jeff James for going beyond his required duties and went 30 feet down into lift station at Burt Estates. Mayor Kernc was appreciative of Jeff James hard work.

Clerk Updates:

Village Clerk Lori Holmes stated the yearly sewer/water rate increase will go into effect on the November 1, 2015 utility bills. Village Clerk Holmes stated she has contacted Locis regarding a GPS/GIS integration and was informed there is none available. Commissioner Johnson stated there is a Google program which might work for the Village. Holmes stated she is looking into other Google Programs for mapping and will get additional information on each.

Commissioner Comments:

Commissioner Kasher:

Commissioner Kasher inquired about the new cylinder for the dump truck and about the additional work that needs to be completed. Maintenance Supervisor Wethington discussed the issues with the dump truck. The valve assembly that runs the truck bed up and down is not working properly. Wethington stated it takes approximately 15 minutes for the bed to go from an up position to a down position. Wethington stated the truck is currently undergoing the repairs for the valve assembly but the cylinder work has been completed.

Commissioner Wilson stated Village Treasurer Sheryl McDaniel has posted the Audit/Fiscal Report and the TIF reports on the Village's website and with the State of Illinois site as required.

Commissioner Wilson stated McDaniel also attended the Illinois Enterprise Zone Conference and learned valuable information from attending the conference.

Commissioner Johnson inquired about the EZ Living business and if a date has been set for them to move to their new location. Mayor Kernc stated there is not a confirmed date and welcomes them to stay at their existing Diamond location for as long as needed.
