New Business

Congressional Spending Request-Will Road Reconstruction Phase 1

Mayor Kernc stated she is pulling this request and will not be pursuing the funding opportunity since this would be from the same funding account bucket the village already received \$600,000.00 for water main and lift stations.

Approve Ordinance #2023-03, Authorizing a Loan Agreement Between the Village of Diamond and IEPA-Water Meter Replacement Project (Terminating Ordinance #2022-14)

Mayor Kernc stated this item will be passed. Village Engineer Mike Perry stated after discussion with Village Attorney John Gallo and Mayor Kernc, the original requested amount will not be terminated. If the village finds lead lines during the replacement project which would exceed the budgeted amount, then those will be noted, and removal and replacement will be conducted at a future date.

Mayor Kernc stated nothing out of the ordinary to report. Kernc did inform the board of a recent carjacking which occurred at Coal City Road and IL Route 113., of which that individual was apprehended. Public Works Department Updates

Public Works Department Supervisor Jim Dunning stated the public works department received bucket truck training and excavator training and all employees passed and are now certified.
