VII. REVIEW OF 2024 ANNUAL REPORT

Village Attorney John Gallo discussed the annual report. The financial statement reflects a beginning balance of \$82,909.00. There is only 1 property in the TIF which is developed and

that is KFC/Taco Bell. That is the only increment which is being received. There was interest received, and the only pay-out was attorney fees which ended the year with a balance of \$95,822.00. Gallo stated this coming year an audit will need to be completed due to the balance will exceed \$100,000.00. Gallo presented the information on the remaining report highlighting the information regarding the re-development agreement with TBS and Jewel/Osco property. Mayor Kernc added, she is hopeful this project goes very well, and the Diamond Market Center will continue to grow and get filled with new businesses.

DISCUSSION

Mayor Kernc stated Heros West Diamond and Culvers will be building in the next year. Questions regarding mapping and zoning were discussed. Kernc discussed pipeline locations on property and the challenges of building on several properties. Several inquired if the TIF will be extended and Kernc responded not at this present time.
